- 1.0 Spend & Win Contest (“**Contest**”) is organised by **AEON BIG (M) SDN. BHD. (Company No. 199201011156 (242659-T)) (“the Organiser”)** from 31st July 2020 until 16th September 2020 both dates inclusive (“**Contest Period**”) at all AEON BiG Hypermarkets nationwide.
- 2.0 By participating in this Contest, you expressly agree to be bound by all the terms and conditions below (“**Terms and Conditions**”).

3.0. Eligibility

- 3.1. This Contest is open to all customers of AEON BiG (“Participants”).
- 3.2.
