Terms & Conditions

(199201011156 [242659-T]) ("AEON BIG") and Visa Worldwide Pte. Limited [200719281K] ("Visa") (Collectively referred to as the "Organisers").
2. This Contest shall commence from 1st October 2022 to 30th November 2022 ("Contest Period"). Entries received outside the Contest Period shall be automatically disqualified.
3.
