1 Rules & Eligibility

- 6.2 "If for any reason, any aspect of the Contest is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of the Organiser which corrupts or affects the administration, security, fairness, integrity or proper conduct of the Contest, the Organiser reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest, or invalidate any affected entries."
- 6.3 "The Organiser reserves the right to disqualify incomplete, illegible, disfigured or late entries automatically or when authenticity of an entry is questionable."
- 6.4 "The Organiser may at its sole discretion, disqualify any entries and prohibit further participation in the Contest by any person whom the Organiser reasonably believes has tampered with the entry process or with the operation of the Contest or who has acted in violation of these Terms and Conditions or in a disruptive manner or for any other reason."
