Terms & Condition

1 Rules & Eligibility

Every participant agrees that these Terms & Conditions have been read and understood and by their participation in the Contest, agrees to be bound by these Terms & Conditions.

1.2 "COLOURING CONTESSST" Contest (hereinafter referred to as the "Contest") is organised by AEON BiG (M) Sdn. Bhd. (hereinafter referred to as the "Organiser"), which is solely responsible for the execution and management of the Contest.

1.3 Subject to Clause 1.4, the Contest is open to all citizens and residents of the Malaysia.

6.2 If for any reason, any aspect of the Contest is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of the Organizer which corrupts or affects the administration, security, fairness, integrity or proper conduct of the Contest, the Organizer reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest, or invalidate any affected entries.

6.3 The Organizer reserves the right to disqualify incomplete, illegible, disfigured or late entries automatically or when authenticity of an entry is questionable.

6.4 The Organizer may at its sole discretion, disqualify any entries and prohibit further participation in the Contest by any person whom the Organizer reasonably believes has tampered with the entry process or with the operation of the Contest or who has acted in violation of these Terms and Conditions or in a disruptive manner or for any other reason.
